This Official Report of the Clinical Mental Health Counseling Program (CMHC) is being distributed in compliance with CACREP Standard I.AA.6. The CMHC Program has fully implemented a Comprehensive Assessment Plan (CAP). The CAP details both the continuous systematic CMHC Program Evaluation as well as the assessment of student learning outcome processes.

The continuous systematic program evaluation collects data from follow-up studies of CMHC graduates, CMHC employers and site supervisors. Also, results from the Counselor Preparation Comprehensive Examination (CPCE) are analyzed. XiTracs is utilized in monitoring measurable CMHC program goals and objectives.

The assessment of student learning involves collecting data on each individual student and includes the learning demonstrated in each course, scores on the comprehensive examination and learning assessed in Internship where the knowledge/skills needed to become a clinical mental health counselor are evaluated using the Internship Checklist and Counselor Competencies Scale-Revised (CCS-R).

In the Fall of 2016 and Spring of 2017 on the CPCE, all CMHC students received a passing score and the CMHC average score was above the national average in each category.

In the Fall of 2016 and Spring of 2017 on the National Counselor Exam (NCE), all CMHC students received a passing score and the CMHC average score was above the national average in each category.

Based on the outcome of the systematic CMHC program evaluations, the following program modifications have been made:


- ' Increased Program Orientation Components
- ⁶ Increased formal programmatic reviews of students to three
- ⁶ Redesigned the process for students to be granted candidacy
- ' Added group interviews as part of the admission process
- ⁶ Hosted regular meetings with practicum and internship site representatives and CMHC students



The diversity of course work and supervision during practicum/internship

ASU CMHC's focus on students and their compassionate approach were both outstanding. Professors and administrators seemed genuinely interested in facilitating student success. As long as the student did his or her part to do the work, the professors and administrators were more than willing to accommodate.

The Faculty were very caring while I was there. The program offers expressive arts training.

Please comment on the one or two least satisfactory aspects of your graduate program.

Text Entry

No training on the healthcare system at large, different MH services offered. Program provided the theory but not the "real world," "day-to-day" reality of clinical counseling.

I wish there were a class that focused more on how to do billing, how to navigate getting paneled with insurance companies, and other aspects of running a private practice.

Faculty transitions/ leaving the program

Finding a fitting internship for one's career interests and area of specialties that a student is planning to go into as a counselor.

Not enough technical or professional, work-related knowledge especially in relationship to counseling administration, governing health bodies in NC such as MCOs, working with managed care, credentialing process how tos, LOCUS assessments, justifications, popular services at different levels of care for medicaid clients, PCPs, and service definitions. Secondly, not enough technical knowledge on how to diagnose clients. There was theoretical knowledge, principles, and basics of diagnoses taught but not techniques on how to most efficiently go about realizing a diagnosis.

The adjunct professor that I had for groups counseling was not up to par and missed several classes. I never understood how she could grade us on facilitation and never see some of is do it.

We had little feedback on our professional disclosure statements in our legal & ethics class. But I believe that has since been addressed and resolved.

Program is not transparent/informative about the fact that graduates will be underemployed or will struggle to find related employment for several years post-graduation until they obtain full licensure. Financial burden has been much greater than expected because of this Redundancy and/or lack of depth in certain courses (intro to cmhc course, ethics, career, especially) wastes time that could be used over the course of the program to gain other important skills (in family/couples work or addictions, for example) without necessarily having a concentration in that area

I felt more guidance might have been beneficial. I concentrated on addiction studies, my desired area of practice after graduation, but wish I'd been steered toward some of the other disciplines during the course of graduate school. Once in practice, I felt underprepared to address patient concerns about mental health issues. My addiction counseling competency was solid, but my general mental health counseling capacity was not. This is primarily my fault; I'm not blaming my advisor. I hope, however, future generations of students will be encouraged to become more well-rounded in their studies. It did not serve me well to be so one-sided.

Expectations were reasonable and I enjoyed my experiences in class. The faculty really care about what they do.

Other comments regarding faculty, curriculum, etc:

The curriculum needs work with regard to practicum and internship. There is not enough education about trauma in the curriculum. We needed more guidance about what to do and when it needed to be done. My practicum and internship experience was not up to par, and I had to find my own placement (not the case with other similar programs in the state). Other comparable programs have better placement options and a more organized way of ensuring that all students in the program get a prescribed level of experience that prepares them for the professional world. There was not a coordinator for practicum and internship and it felt very disorganized and lacked consistency.

Well, my primary professors where Keith, Gerry, Jack, Sally, Hakan and Kristina. I think only Galvin and Miller are still there. I learned so much from all of them. I will say, that as unorthodox as Jack was, his teaching about family systems comes into play all the time in very practical ways, and ironically, maybe more practical then all the other learning I received--even though students may not be able to see that at the time. Being intentional about teaching good skills, family systems and watching a extremely skilled clinician work and explain, is something I would encourage HPC to continue.

As I have said many times before (and will continue to say!): I would not have traded this program for any other program in the universe. Other strengths of this program that I experienced included its focus on self-care, the high-quality supervision that was provided during field experience, and the amount of guidance and education given around navigating and understanding the licensure process. Much gratitude to the faculty that have made this program awesome-I can't wait to see how it keeps growing!

I loved the EXA program and wish I had kept better notes on all the activities we did!
